IOWA CITY, IOWA: Pediatricians are among America's most-trusted allies for information on children's health. Now they are lending their expertise to address a public health crisis affecting thousands of families—teen driving deaths. The Allstate Foundation and eight chapters of the American Academy of Pediatrics (AAP), chosen through competitive proposals, have joined forces to combat this epidemic and educate communities on the importance of stronger graduated driver licensing laws. The AAP recommends that states adopt, improve and enforce these laws for teen drivers.

In the decade from 2000-2009, more than 81,000 people were killed in crashes involving drivers age 15 to 20. Each year nearly 4,000 teens are killed on America's roadways. While the numbers are staggering, graduated driver licensing policies have been proven effective by more than 70 studies and shown to reduce crashes by up to 40 percent.

"Allstate and The Allstate Foundation are committed to making sure that no American family has to deal with the loss of a loved one due to a teen driving crash," said Vicky Dinges, vice president of public social responsibility at Allstate. "The AAP lends a credible and respected voice to this initiative and will help to give communities the tools and education needed to protect our most valuable asset—our children."

The Iowa Chapter of the American Academy of Pediatrics (IA AAP) will address the need to enhance Iowa's current graduated drivers licensing (GDL) system by delivering targeted community education related to SF 184, integrating Iowa pediatricians into grassroots advocacy strategies and efforts. "The current GDL structure was enacted in 1999. New research demonstrates that a more comprehensive GDL structure better protects teen drivers and Iowa's GDL system is not adequate," said Dr. Ken Cheyne, IA AAP President. "Passage of SF 184 will greatly improve the safety of Iowa's teen drivers and, by extension, all drivers in Iowa."
